

## Sponsor Hole Rules & Agreement

The hosting company is allowed 4 (four) sponsoring holes on the course at R700.00 per sponsor hole. If they wish to have more than 4, an additional fee of R750 per hole will be charged to the hosting company main invoice.

ICC does not accept any delivery of branding/items prior to the Golf Day.

Sponsor Holes can arrive on the day and will be escorted via a Marshal with their vehicle to their designated hole.

It's the sponsoring holes responsibility to setup and breakdown their own branding for the day. ICC reserves the right that should branding be left on site, it will unfortunately be disregarded two weeks after respective Golf Day.

Once the vehicle is at the designated hole, it is not allowed to drive up and down throughout the day, we have irrigation systems on our course and the Hosting company will be held liable for any damages or any additional fees of sponsoring holes that has not been settled.

The Hosting company will be allowed for deliveries 1 day prior to the Golf Day, only when prior arrangements has been made.

### Food & Beverages:

Sponsoring holes are more than welcome to be put in touch directly with the Events Manager to arrange beverages & snacks for their hole. [events@irenecc.co.za](mailto:events@irenecc.co.za)

ICC & the sponsoring hole can arrange directly between one another for items and invoicing.

The sponsoring company has one of 3 choices with regards to beverages:

1. Select items from ICC's beverage list, we will then ensure that the beverages/snacks get delivered in time prior to tee off. All beverage orders must please be made in quantities of 6 (six). Please note, that the name and authorised personnel must be provided to ICC and must be present on the day. We will ask for signature on goods received and returned to the club.
2. Corkage. The sponsoring hole is allowed to opt for corkage fee of R2500. They are more than welcome to then bring in what they wish to. However, should this be their option, they must provide their own ice, ice tubs, tables and chairs for the day. They can however order ICE prior to the time with the Events Manager.
3. Barter 1:1 – this agreement is mostly for suppliers that will be partaking in a Golf Day on ICC premises. If you bring in a case of beer you need to give a case of beer to Cursive. Please note that the beverages on barter agreement must be stock that Cursive stocks in our bars.

All beverage orders & arrangements must be done no later than 7 working days prior to the Golf Day. We can only stock a certain amount at the club, and we will not be able to assist on the day for top ups. ICC cannot guarantee stock items, this is dependent on external suppliers.

The sponsor hole must be manned throughout the day by a representative of the sponsor hole company.

ICC Marshals will roam throughout the day on the course in their Marshal Carts (red golf carts). Should you or your team need to come to the club house for bathroom facilities, food etc. they can make use of the Marshals. Sponsor holes to phone into the office if a Marshal isn't seen fast enough.

If the sponsor hole ordered ice, we do two trips throughout the day. First trip with ice on the stock that you have received and sign for, second trip 2.5hours into the day.

Sponsoring companies must arrive at the course 2 (two) hours prior to tee off. This is to ensure sufficient time to setup the course and deliver stock if needed.

No golf carts are reserved for sponsor holes unless the Hosting Company has arranged additional golf carts specifically for them.

There is one public bathroom on the course, which is situated at hole 3. The holes that are close to it are as follow: 4, 5, 6, 16, 17, 18 – it's close but still a distance to walk.
